W.P. 2098(W) of 2010 Sri Bimal Chandra Ghosh -Vs- State & orthers:- 1. Judgement of Hon'ble High Court dated 8-9-2010 2. Appeal suit filed by Himadri Mukherjee vide No. AST 617 of 2010 with ASTA 238 of 2010 and final judgement passed by the Hob'ble H.C. dated 10-12-2010.

The matter discussed in the meeting thoroughly and it was resolved that (1) in compliance with the order of the Hon'ble High Court, Calcutta vide W.P. No.2098(w) of 2010 read with AST 617 of 2010 with ASTA 238 of 2010, Shri Himadri Mukherjee, Prop. of Tarama Motor Training School, Bethuadahari, Nadia is not allowed to use Heavy passenger motor vehicle for taking driving test for the purpose of issuance and renewal of driving licence(HPMV) with immediate effect, which he was allowed vide this office memo.no.164(2)-M.V. dated 05-02-2010. Secretary, R.T.A. , Nadia will communicate this decision to Sri Mukherjee immediately.

(2) On the other hand , as regards, complains received from Nadia District Motor Employees Union dated 16.12.2009, Nadia Zilla Motor Shramik Union dated 18.12.2009 and 13.01.2010 by this office, Sri Bimal Ch Ghosh Prop Nadia Motor Training School , Chasapara, krishnagar, Nadia will be asked to show cause as to why action will not be taken against him, if the allegation is true, as per rule. The Additional District Magistrate ( General), Nadia is requested to issue show cause notice to Sri Bimal Ch. Ghosh and necessary action may be taken accordingly.

- 7) Delegate of power under the provisions provided under Rule 213 of W.B. Motor Vehicle Rules 1989.  
  
Delegate of power under the provisions provided under Rule 213 of W.B. Motor Vehicle Rules 1989 to present R.T.O. Malay Ray W.B.C.S. (Exe) to act as Secretary R.T.A.Nadia with restrospective effect from 29-06-2010 subject to the restriction and limitation as specified below:
  - i) Power under Sub-section (1) of Section 76 of M.V. Act 1988 to grant, refuse or renew a private service vehicle permit.
  - ii) Powers under section 66 and 79 of M.V.Act 1988 to grant goods carriage permit.
  - iii) Powers to renew goods carriage, contract carriage permit and stage carriage permit under section 81 of M.V.Act 1988 and to renew counter signatre of any such permits.
  - iv) Powers under section 82 of M.V. Act-1988 to transfer permit.
  - v) Powers under section 83 of M.V.Act 1988 to allow replacement of one vehicle by another.
  - vi) Powers under sub- section (8) of section 88 of M.V.Act 1988 to grant special permit to different type of passenger carrying vehicle.
  - vii) Powers under section 86 of M.V.Act 1988 to suspend a permit or to recover from the holder thereof the sum money agreed upon in accordance with sub-section (5) of the said section( other than power to cancel the permit).
  - viii) Power to issue of time table, transfer of owner ship of any type of vehicle, contract carriage permit as per rule.


