
Applications are invited from Citizens of India as defined in Part-II of the Constitution of India for appointment to posts of (1) **Nirman Sahayak** [Approx-15, (Gen-06, SC-03, ST-05, OBC-01)], (2) **Block Informatics Officer** [1, (ST-1)]. ST vacancies include the backlog vacancies. There will be a panel for each category of post in addition to the notified vacancy, which will remain valid for one year from the date of publication of result.
Scale of Pay : Post (1) Nirman Sahayak & Post (2) Block Informatics Officer- Rs. 7100-37,600/- + G.Pay 3900/- Pay Band-3].
Age : For the post no. (1) & (2) 18 - 37 years as on 1st January, 2009. Upper age limit for other posts is relaxable for SCs, STs, OBC in terms of Rules and Orders issued by the State Govt. from time to time.
Qualification: For Post (1) (a) Diploma in Civil Engg from any Institute recognized by the State Govt. / Central Govt. For Post (2) Bachelor's Degree on Computer Application or Bachelor's (Hons) Degree in Computer Science or Bachelor's Degree in any stream with 'A' Level Certificate course of DOEACC. Candidates with qualifications of 'B' or 'C'

Level Certificate course of DOEACC with 3 years' Diploma in Computer Science and Engg. / Information Tech. / Electronics and Tele-Communication shall also be considered.

The applications in the prescribed proforma with attested copies of mark sheets of all academic examinations passed and certificates of age, educational qualifications, computer trainings and experience, (if any and two recent passport size photographs should reach the **District Panchayats & Rural Development Officer, Nadia, Collectorate Building (2nd Floor), P.O. Krishnagar, Pin-741 101, Dist. Nadia by 5 P. M. on 25th November, 2009.** The envelop must be superscribed with the name of the post for which application is being submitted. Application can be dropped in the drop box kept at DP&RDO's Office on any working days during the office hour. Application by Regd. Post only will be accepted. Application by Courier Service will not be accepted. The authority will not be responsible for any postal delay in the matter of delay in receipt of application.
Mere submission of application does not confer any right upon the candidate to be called for the Selection Test. Incomplete application will be summarily rejected. Candidates will be selected through written, viva-voce

and for BIO in addition to these through a computer test. The schedule of examination will be intimated to the candidates through call letters before commencement of written test.
