**Annexure I: Hardware Items required for LAN**

Bid has to be submitted on TWO-ENVELOPE basis, First envelop (technical Bid) should carry the credential and experience of agencies in the field. Tender Cost and EMD (Earnest Money Deposit) in the form of demand draft are also to be enclosed in the Sealed Envelope. In absence of tender cost and EMD, tender will be summarily rejected.

- (a) Price Proposal to be enclosed as per proforma.

**Annexure II: Fibre optics backbone material and implementation charges.**

- (a) Bid has to be submitted on TWO-ENVELOPE basis, First envelop (technical Bid) should carry the credential and experience of agencies in the field. Tender Cost and EMD (Earnest Money Deposit) in the form of demand draft are also to be enclosed in the Sealed Envelop. In absence of tender cost and EMD, tender will be summarily rejected.

**Annexure III: Implementation charges for Interna. LAN for Distribution of Line from OFC backbone for laying Cat 6 cable, fixing I/O port, Rack and Electrical Points with electrical fittings, Board, switches, main switches.**

- (a) Bid has to be submitted on TWO-ENVELOPE basis, First envelop (technical Bid) should carry the credential and experience of agencies in the field. Tender Cost and EMD (Earnest Money Deposit) in the form of demand draft are also to be enclosed in the Sealed Envelop. In absence of tender cost and EMD, tender will be summarily rejected.

- (b) Price Proposal to be enclosed as per proforma.

**Any bidder who wants to participate shall have to bid for all three annexures.** Tender Cost and Earnest Money Deposit shall also be submitted separately.

All bidders willing to participate shall have to submit copies of up-to-date IT returns, VAT, Trade License, Professional Tax certificates. It may be noted that mere production of enrolment certificates is not sufficient; the tenderers have to submit at the time of dropping of tenders up to dates returns (in the form of Challans etc.) of Taxes noted above.

They shall have to submit requisite credential in terms of works executed of similar nature in an organization. Credential shall be accepted only in the form of Credential Certificates / Payment certificates issued by competent authority. The decision of tender committee in the matter of credential and eligibility of the participating agencies is final and absolute.

Tender specific Authorization from Hardware manufacturers and compliance statement duly signed by the intending bidders shall be submitted.


Rate should be quoted including cost of 5 years' warranty for active components and maintenance of network cables (CAT 6 and OFC) also for five years shall be submitted.

ISO certification of agencies is desirable.

The successful bidder shall have to enter into an agreement entailing conditions for strict compliance.

1. Period of contract : Six months from the date of award of work.
  2. Period of execution : Two months from the date of award of work.
  2. EMD :

Rs. 10000/- (Rupees ten thousand only) for items noted in Annexure III
  3. Mode of payment : Tender document could be purchased by applying cost of bid document Rs. 500/- either in cash payable at Nazareth, Nadia or DD drawn in favor of the District **Magistrate, Nadia** payable at Krishnagar. The same can be downloaded from [nadia.nic.in](http://nadia.nic.in) in which case, the cost of the tender documents of Rs. 500/- is required to be paid in the form of crossed DD drawn in favor of **District Magistrate, Nadia** and enclosed to the tender documents. EMD is to be paid in the form of Crossed Demand Draft issued by a scheduled bank, drawn in favor of **The District Magistrate, Nadia**.

  5. Time & Date Bid opening: 14:30 Hrs of 12.8.11
  7. It is mandatory that the intending bidder shall be able to supply all the items put to tender and hence they have to quote for all the items in particular Annexure, failing which the tender is liable to rejection.
  8. The tender, which is not accompanied by the requisite EMD and relevant documents as enumerated in the NIT shall be summarily rejected. Tender will not be accepted/received after expiry of date & time. The District Magistrate, Nadia reserves the right to reject any or all tenders without assigning any reason what-so-ever.
  9. The rate should be exclusively for **District Magistrate, Nadia**
  10. The technical/commercial bids should be in two separate sealed covers clearly marked as TECHNICAL BID and 'COMMERCIAL BID'. The bid has to be accompanied by an Earnest Money Deposit (EMD) and Tender Cost of requisite value in the form of a demand Draft in favor of "The District Magistrate, Nadia", payable at Krishnagar. Such Drafts should be in separate third cover marked as 'EARNEST MONEY DEPOSIT'.

- The TECHNICAL BID should include the name and address of the firm/company, annual turnover, details of past experience and the offices where they have been performing such duties along with the supporting documents/certificates. Technical Bids should not contain any commercial quotes.
  - The COMMERCIAL BID should contain the rate against each item separately. The quoted unit rate will be considered for evaluation purpose. All sections of relevant annexure should be properly filled up.
  - Technical and Commercial bids should be in clear words, categorically mentioning each and every term specifying the rates, etc. Any kind of ambiguous/obscure/unclear terms would lead the firm's bid being disqualified.
11. The rates quoted should be legible. Pencil entries and over written entries shall be rejected.
  12. No sub letting of contract is allowed.
  12. The offers which do not conform to the conditions laid down in the tender notice shall not be considered.
  13. The District Magistrate, Nadia reserves the right to disqualify such bidders who had a record of not meeting the contractual obligations against earlier contracts entered into with the authority.
  14. In case bidder has any query they can contact DIO, Nadia at the office of the District Magistrate, Nadia.
  15. District Magistrate, Nadia reserves the right to reject all or any tender without assigning any reason whatsoever.

  18. Maintenance charge per year should be mentioned in the financial bid.


