Sealed tenders are hereby invited from reputed Hoteliers, Restaurant Owners & Caterers having food license from appropriate authority for supply of hygienic, delicious and quality Tiffin, Lunch and Dinner packets as per enclosed specification for distribution amongst the staff and officers engaged with General Election to Assembly, 2011.

The candidates, intended to submit tender for supply of food - items, will have to deposit Rs.3000=00 (Rupees Three Thousand) only by Bank Draft to be pledged in favour of the District Magistrate, Nadia as Earnest money in absence of which the tender paper will be treated as cancelled.

The candidates, intended to submit tender only for supply of tea & biscuits need not to deposit any earnest money.

Clearance certificate (up-to 31<sup>st</sup>. Jan, 11) of Sales Tax, Income Tax, Professional Tax, Trade Licence should have with tender paper.

Credential in same nature of works i.e. supply of bulk food packets & supply of tea in the programme Distribution, Reception, Counting etc. if any, should be attached with the Tender paper.

Selected tenderers, before taking up the work, will have to execute agreement in Non-Judicial Stamp paper regarding smooth & timely completion of the assigned work. **The selected firm for supply of food pkts. will also have to deposit a Bank Draft of Rs.15,000/- (Rupees fifteen thousand ) only in favour of the District Magistrate, Nadia before taking up the work.**

Any dislocation, delay, willful negligence will make this office compelled to forfeit the entire claim without assigning any reason whatsoever & initiate penal action against the defaulting agency as per rules. Moreover, there will be no compromise on quality. If at any time quality is found to be objectionable, contract will immediately be cancelled.

No General Order-Supplier (Govt./Non-Govt./ Co-op.) will be allowed to participate.

Rate of tiffin / Lunch / Dinner packets should be inclusive of all cost of hygienic packaging with Aluminium foil and carrying up-to the venue from the supplying point.

The tender in prescribed manner quoting the rates in figure and words, should reach the undersigned on or before **28.03.2011** by 1-00 P.M.. Tender box will be kept at the office chamber of Nezarath Deputy Collector i.e. Officer-In-Charge, Infrastructure Cell.

**The tender should be given Printed Pad of the Firm / Individual.**

The tenders will be opened on the same date i.e. **28.03.2011** at 2.30 p.m in the Chamber of the ADM (Dev.), Nadia Collectorate, Krishnagar, Nadia and willing tenderers may remain present at the time of opening the tenders.
