TENDER NOTICE

Sealed Tender are invited for development of Dynamic Web Site on behalf of District Health & Family Welfare Samiti of Nadia by the undersigned from reputed firms specialized in development and maintenance of website so as to reach the office of the district Programme Management Unit, of the Chief medical Officer of Health, Nadia, 5, D. L. Roy Road, Krishnagar, Nadia with in 07/03/2011 Up to 3p.m. and will be opened at 3:30pm the same day at CMOH chamber.

The tender should comprise all documents pertaining to technical specification, experience, list of jobs undertaken along-with the amount of offer in Rupees.

Special conditions to carry out the work:

1. The rates should be quoted inclusive of all taxes. It should include charges for development, Testing, Training if necessary.
2. The applicant should have experience in the field of development of website relating to Govt. sectors / public sector undertaking.
3. The agency should maintain the website free of charge for one year including major modifications for first six months starting from inauguration and minor modifications for next six months along-with uploading.
4. The Website will be developed using ASP.NET 1.1 or after and MS 2000 Advance Server or after. Entries of various forms may be done in offline and than can be uploaded and reports should be generated in HTML as well as in MS EXCEL in a properly formatted ready-to-print mode with graphical representation for comparison. The website must be properly menu-driven including Tier-wise login, audit trail, GOs, Notices, forms, reports, feedback,-etc. (the names may vary).
5. The website shall be completed in three Phase. Phase -I (includes regular monthly reports on Public Health, Family Welfare & hospital reports e.g. RT7, etc.) Phase - II (includes some special programme reports e.g. pulse polio etc.) Phase-III (includes various analysis, MIS etc.).
6. The agency will be responsible for collection of required health related data, information, photographs and related material for hosting the website.
7. The approved agency shall be able to provide the service within a period of one month from the date of communication by the District Health & Family Welfare Samiti of Nadia for this purpose.
8. The decision of the Application Inviting Officer for acceptance / rejection of any proposal are final.

9. Source code for the proposed Dynamic Website will be given to the DH&FWS, Nadia before submission of bill by the party and it will be treated as property of DH&FWS, Nadia.
10. Only on satisfactory completion of the supplies ordered for installation and hosting of website the amount of all bills of the suppliers made will be admitted for payment.
11. The agency who is awarded the work shall provide the demonstration of the actual website, its operation and use and get it duly approved before its actual hosting on the web.
12. The intending tenderers shall have to deposit Earnest Money of Rs 15,000/-. Such amount may either be deposited in the State Exchequer to the credit of the concerned authority, under the head of account "8443-00-103-001-07-civil deposit-Deposits-Advance (F)-Deposits not bearing interest-XXI other Deposits" or given as Bank Demand Draft in favour of CMOH and Member Secretary District Health and Family Welfare Samiti, Nadia. The Earnest money deposited shall be forfeited if the successful tenderer withdraws his tender after opening of his tender & if he fails to execute the written contract after communication of the acceptance of his tender or refuse partially or wholly the offer made by the C.M.O.H., Nadia on behalf of the Governor of the State of West Bengal.
13. Deposit money 10% of the agreed value.
14. The tenderer or his/her authorized representative should duly sign each page of the entire tender documents personally. No space should be left blank.
15. Tender must be accompanied with duly attested Xerox copy of up to date valid Sale Tax/V.A.T Registration Certificate, P.Tax, Income Tax clearance certificate/ P.A.N No. Trade License & previous credential if any & required earnest money deposited challan duly receipt by the Treasury Challan in duplicate/ Bank Demand Draft addressing to the CMOH and Member Secretary District Health and Family Welfare Samiti, Nadia & tender form in duplicate duly filled in & signed, failing which it shall not be considered as valid & liable to be rejected.
16. The brief description of website on para no. 4 & 5 may be change within the period.
17. Selection will be made on the basis of total price given by the tenderer, no item wise price will be consider.
