
Subject: Clarification regarding empanelment for supply of cooked diet.

Since correspondences are being regularly received from the C.M.O.H.s of the districts seeking clarification on regarding participation of empanelled agencies in the supply of cooked diet, it has become necessary to issue a clarification in this regard.

Consequent upon this, the under signed is directed to say that the contractors having been empanelled in higher classes of hospitals for supply of cooked diet in the Govt. hospitals can participate in the tender in lower classes of hospitals also but not vice versa, i.e. the agencies empanelled under lower classes of hospitals are not eligible to participate in the tender in higher class of hospitals.
